RUN ALEX RUN stalked the pace three wide, ranged up to take control turning for home, garnered a larger advantage when straightened for home, all out to hold off the runner up in the final strides. CRIMSON KING CAT hammered at the start from both sides, raced back, rallied, split foes willingly with less than a furlong remaining, finished well to miss the nod. LUMBERJACK CAT lacked speed, lodged a middle move five wide to be closer turning for home, flattened a bit in the final furlong. ESPOOF set the pace for a half while in hand, weakened in the drive. SEQUOIA KING pressured the pace in hand and off the inside, little left for the late going. SOLID TRIP always outrun.
