TOURISMO steadied early after not breaking with the field, rushed up, took up late backstretch, waited late in the turn when in traffic,moved out when straightened for home, full of run to win going away. PRETTY BOY FOREST forwardly placed vied up front off the inside, showed the way past the furlong marker, no match for the winner late. GLORY CREEK off the early pace, came four wide into the lane when advancing, flattened out in the late going, finished up best of the rest. LAKE LUCERNE with the pace along the inside, weakened in the drive. SIOUXBOY broke sharp, set or forced the pace, faltered in the drive. VALID MYTH off the pace, came five wide into the lane when making a mild advance, went evenly in the late going. BIG RED BARS sluggish early, some belated interest. ZOIE'S RUN lacked speed, four wide into the turn, dropped inside, lacked a late response. GO 'EERS five wide through the turn, lacked a rally. WHAT A PLACE lodged a mild middle move, faltered in the drive. BLUESKIN steadily faded. MURPHY'S STORM CAT stopped after a half.
