HILARIUM broke out, showed the way early through a quick opening quarter, shook clear in the turn, increased advantage through the lane while being kept to task. S C REDSLEGACY pinched back at the start, raced back early, steady advance rail, finished willingly to be clear for the place, no threat to the winner. BELONG TO B'SAL back off the early pace, closer in the two path into the lane, forced in, tight quarters a furlong out, finished up best of the rest. FOLLOWING A STEWARDS' INQUIRY REGARDING THE STRETCH RUN, THE RESULT WAS ALLOWED TO STAND. COUNSELOR RON off the pace while racing outside, came four wide out of the turn, finished up evenly in lacking a serious late kick. ANTEROS forwardly placed in the early going, moved out entering the turn, second flight upper stretch, lugged in under a right handed stick to tighten up inner rivals with a furlong remaining, weakened. LET'S FACE IT off a bit slow, raced well back, dropped toward the inside for the turn, continued under restraint upper stretch, displayed some belated interest after the issue had been decided. WESTERN RANGE within striking distance, fell back, between rivals out of the turn, lacked a response in the drive. DELIVER THE STORM failed to rally. SONS OF MISSOURI lacked speed, well out in the strip, raced five wide through the turn, remained back. CONSOLIDATION broke in, straightened, pressed the winner early, was giving way when forced to check in tight quarters a furlong out, continued to fade. SCOTT MAN fell far back, distanced after losing contact with the field.
