**Footnotes**

MOMENTARILY bumped at the start, dropped toward the inside in the first turn, closer inside, boxed second turn, moved out, finished willingly to be up in time. CITIZEN JOHN set the pace, clear in the run up the backstretch, shrugged off a bid in midstretch to briefly get clear, gave ground grudgingly to the winner. SWEETSOUTHERNSTYLE stalked the pace from off the inside, lodged a bid from the outside turning for home, lacked a winning punch in the late going. RAVENSWORTH pressed the pace while just off the inside, had little left in the drive. BATTEN within striking distance three wide, also came up empty in the drive. DUKE OF PEARL jostled start, remained well back throughout. JUMPONTHEBANDWAGON five wide into the first turn, was finished early.
