Footnotes

STAGE ROMEO pressed early inside, dueled through the turn closest to the inside, shook clear, kept to task. DEVIL AND A HALF forwardly placed in the second flight off the inside, roused turn, no match winner in the drive, second best. MR CHUCKLES in the second flight early toward the inside, moved out, three wide, between foes turning for home, lasted for the show. CRUZIN COWBOY broke in, brushed, lacked speed, four wide into the lane, went evenly through the stretch. BLUES DISTRICT set or forced the pace while off the inside, between foes into the lane, gave way in the drive. STORM TREE roughed at the start, settled off the pace, came five wide out of the turn, lacked a kick in the drive. STORMIN SIDNEY off pace, four wide early turn, fanned six wide turning for home, failed to rally. MAGICAL STORM bumped, came in start, fell far back, bothered suddenly nearing the furlong marker when REPEAT IT AFTER ME veered out, finished up evenly. NEMAHA COUNTY dwelt at the start, far back, was never a threat. REPEAT IT AFTER ME forced in at the start, moved up, was tiring a bit, ducked out stretch, continued to tire. SHARKASELLI wiped out start, trailed throughout.
