R NANALEE with the pace from the start, dueled, vied through the turn while remaining along the rail, shook clear into the stretch, kept to task the final furlong. MISS SEVEN K off a step slow, advanced steadily the opening quarter, closer, steadied in traffic late in the turn, got through, moved out, held sway for the place while no threat to the winner. LOST CAT back off the pace, ranged up closer five wide turning for home, managed a mild rally late, just up for the show. GRAY LADY PARTEE off slowly, steadied, raced well back early as a result, was fanned seven wide turning for home, improved position down the center of the strip. AUTUMN IN MAINE settled off the pace and the inside, in some traffic turning for home, roused, came up empty for the drive. BLESS JESSICA R in the second group while racing off the inside, loomed a threat four wide late in the turn, lacked a further response in the drive. MISTY GROVE back off the pace while inside, saved ground in the turn, saved ground through the turn, moved out, continued evenly to the wire. DADDY'S APPROVAL failed to menace. CHERISHABULL remained always back. SMOKEY JUELS moved up after the start, vied into the turn, gave way. L J'S BERTIE vied early outside the winner, was floated out six wide turning for home when beginning to tire, continued to fade to the wire. MI LADY A off slowly, trailed throughout in showing little.
