Footnotes

GOINGOINGONE broke alertly, dueled inside while firmly rated, disposed of the other speed in the second turn, clear into the stretch, not threatened to the wire. VICTORY COURTS moved up to duel while outside the winner, remained on equal terms with that one up the backstretch, could not keep up the final quarter, clearly second best. CONTE moved up to be closest to the leaders after a quarter, chased that pair through the second turn in the three path, could not keep up in the drive, saved the show. ZELLERS bit slow to settle while four wide into the first turn, settled in the run up the backstretch, modest rally to be gaining for the show. DISTINGUISHED OKIE raced far back after hesitating at the start, continued to trail, moved out 4-5w into lane, passed tiring foes down the middle of the strip. BAND OF SILENCE bothered, carried wide in the first turn, continued outside, four wide in the second bend, lacked a kick in the drive. MONEY ZAPPER squeezed back at the start, remained back. FASTFORWARDIT hesitated at the start, improved slightly into the lane, never dangerous. HOGUE void of speed, roused with five furlongs remaining, failed to respond in a dull effort. CELINA DIAMOND settled well off the pace, backed up. LEROY HERMAN bore out in the first turn, stopped.
