SHE'S A REBEL TOO void of early foot, roused for the drive, split foes late and closed willingly to be up for the place. BOSTON EXPRESS pressured the early pace, took over in hand and off the inside late in the turn, showed the way by daylight past the furlong marker, no match winner, nipped late for the place. CITY FIRE off the pace into the stretch, did not have enough late kick. GOLDLEAFED MIRROR broke sharp, early pace, weakened in the drive while toward the inside. NIKKI'S GROWL forwardly placed, gave way.
