ASHEN LORD within striking distance toward the inside, briefly boxed late in the turn, moved to the outside for the drive, finished with good late energy. NEVILL'S MISTAKE bothered slightly at the start, pressured the pace three wide, took over late, no match. HANGMAN broke out, vied up front off the inside, led between foes past the furlong marker, weakened in the late going, comfortably clear for the show. SMILIN' DEL last away, trailed well back, angled out, showed some belated interest. CACTUS TOWN broke on top, with the pace along the inside, weakened in the drive. FULL SCRIMMAGE bothered at the start, failed to menace. KIPPERSOL pushed out start, never a threat.
