RUNNING SHOES closest to the leader while under restraint, collared that one from the outside turning for home, drew well clear. CASA LIMA got clear not long after the start, set the pace for a half, no match for the winner in the drive, saved the place. NOON DELIGHT settled off the pace, saved some ground through the turn, lacked a winning response in the drive while slowly getting to the runner up. QUIP'S JET lacked speed, angled out when asked for some run turning for home, improved position while not a serious threat. TENNESSEE TODDY off a bit slow, raced back and off the inside, made little impact in the drive. RED HEADED WOMAN between foes when turning for home, lacked a response. REMEDY within striking distance, had nothing for the drive. TRICKSTER'S QUEEN off slowly, raced back, fanned out six wide turning into the stretch, managed little in the way of a rally. RISKY ROSE remained back throughout. SHE'S DE GRAY was tiring when pushed out five wide into the stretch. LUCY CEE'MORE forwardly placed in the early going, stopped.
