RUE DES REVES well back early, began to move early in the second turn, angled out to engage the leaders turning for home, proved best. SEVEN DECEMBER chased early, took over from the outside turning for home, engaged by the winner soon after, proved stubborn, clear for the place. PHONE JOAN cleared to the inside the opening quarter, set most of the pace, weakened in the final furlong. ROSIE'S RISK off a bit slow, moved up, went evenly throughout. HOPE SPRINGS UP back early, mild advance the middle half, flattened out in the drive and was also going evenly under the wire. JULVIYA forwardly placed for a half, faded. WITCHONABROOMSTICK steadied in the first turn, fell back, lacked late bid. MITH AMERICA was finished early. SCARLET MISS faded. DOUBLE FREEZE trailed throughout.
