STORM'S TOUR close from the start, challenged turning into the stretch while three wide, drew clear late under firm handling. DORVAN off the early pace, advanced into contention four wide through the turn, could not match the winner late, gained the nod for the place. DUSTBALL narrowly set the pace, continued to show the way through the turn, weakened a bit late, missed the place. ILE ST. LOUISVILLE void of early foot, five wide out of the turn, displayed some modest interest down the middle of the strip. STORM TREE off the pace, three wide through and out of the turn, lacked a late kick. HOT DIGGITY DOG dwelt at the start, raced well back early, improved position after the issue had been decided. HALF MOUNTAIN CAT pressured the early pace, vied between foes into the stretch, faltered. SMART REALITY within striking distance along the inside, in a bit tight late in the bend, faded. BOOGIE DISTRICT off slowly, was never a threat. QUEENIE'S EPIC tired from early efforts. MR CHUCKLES had nothing for the drive. STORMIN CELEBRITY was through early.
