THATS DANCING lost footing at the start, soundly bumped start, steady gain, moved inside, bid, best FOLLOWING A STEWARDS' INQUIRY REGARDING THE START, THE RESULT WAS ALLOWED TO STAND. YOUCANSEEMECOMING settled off the pace, five wide late in the turn, moved out, no match winner, just held the place. PROPER ONE in tight at the start, bobbled, fell back, steered out for the drive, finished up willingly on the far outside late. ARKY SPRING'S narrowly set the pace, garnered a larger advantage in the turn, weakened when confronted in the drive. PAIGE'S FOREST pressured the early pace, chased through the turn, weakened in the drive. MEAFAREL'S REWARD void of early foot, in traffic late in the turn, improved position drive without posing a serious threat. DESTINY GAYLE bumped hard at the start, moved up mid pack, failed to menace. CHERRY DANCER lacked speed and the inside, did not rally. LA TE DA LANEY bothered at the start, remained back in failing to menace. TIME TAMER fell back to trail, failed threaten. MARVELOUS PEACE forwardly placed for a half, stopped. LOU ISA JANE stopped, distanced.
