GRAND FOREST moved up a bit into the turn off the inside, came five wide into the lane, slight drift, dueled late, edged clear under firm handling. HEART'S OF GOLD fell back off the pace, stalked the first flight into and through the turn, four wide and inside the winner turning for home, vied with that foe while also drifting in a bit, no match late, clear for place. CITY SLEWTIONS vied up front closest to the inside, slightly larger lead past the furlong marker, had little for the top two late. VICTORIA MISS vied up front while three wide, weakened in the drive. BOUVIER void of early foot, continued back, improved position, no real threat. DEVIL'S PRIZE slow to begin, continued to trail turn, showed some belated interest to also improved his status through the lane. MINNESOTA THUNDER made little impact. HEAVENLY LIONESS was never a threat. AWESOME VALUE vied up front while between foes for a half and gave way. GOT IT TOGETHER lacked a rally. GHOSTLY APPEAL tired from early efforts. TRIPLEMENTAL gave way while five wide.
