PAISANO CREEK trailed early behind a fairly lively pace, began to advance toward the inside in the second turn, bid, finished willingly between foes, proved best. BADGER BO off the pace, ranged up boldly into contention late in the final turn, pushed out to be six wide into the lane to lose some momentum, not enough in the late going. NUMISMATIST steadied early in the first turn in traffic, stalked in the run up the backstretch off the inside, benefited when SHRADED EDGE bore out under a left handed stick turning for home to bother several foes and open a sizeable hole toward the inside, darted through, briefly led, not enough late. SHRADED EDGE dueled up front off the inside, held a narrow advantage exiting the final turn, bore out sharply when struck left handed entering the stretch to bother several foes to his outside, straightened, finished up evenly. NINTH CLIENT forwardly placed, between foes when bothered, pushed out turning for home, weakened. MY FRIEND NEV prompted the pace while four wide in the run up the backstretch, bothered, put in tight exiting the final turn, faded in the drive. KISS MY KRISS was not a factor while racing on the outside into the lane. ALMIGHTY ADVERSARY narrowly set the pace, stopped late in the final turn. UP COUNTRY was finished early, far back.
