**Footnotes**

NUMISMATIST allowed the pace to go early while saving ground, asked for a bit more into the far turn, moved off the inside for the drive wore down leader. HOUSE OF USHER set the pace along the inside, disposed of the other speed turning for home, gave ground grudgingly to the winner. NAVY WINGS four wide into the first turn, prompted the pace in the run up the backstretch, had little left for the drive. ROADSTER off slow, fell far back to trailed, improved by picking off a couple of tiring foes. GOLD NINER pressed off the inside, gave way in the drive. HOLD'EM TIGER five wide into the first turn, continued to race within striking distance, also backed up in the stretch.
