### Footnotes

FAVORABLE VERDICT away in good order, angled in entering the first turn causing three inner rivals to steady, set a quick pace, remained clear in the drive while drifting down the lane. MADAM FLATTER BY off slowly, raced well back in trailing for a half, steady advance off the inside, in time for the place. LUCKY SPANX in the second flight, steadied into the first turn toward the inside, chased the winner through the second turn and into lane, had little the final furlong, caught for the place. JAM JAR JANIE went one paced off the inside. DEVOUT DIVA steadied into the first turn while between rivals, settled off the pace, began to fade far turn. BUBBA PRINCESS lacked speed, was never dangerous. STAR SUSPECT first rated early along the inside, lacked a bid when asked for the drive. MAMAJESUSANDJONES steadied across FAVORABLE VERDICT'S heels when that one angled in entering the first turn, closest to that same rival for five furlongs, stopped.
