Footnotes

NOT A ROCKET off the pace while four wide through the turn, continued four wide upper stretch, roused, finished up with good late energy to be clear late. JOSHKA BOTCHIE off the pace, came four wide out of the turn, rallied for the place, no real threat to the winner. RONDEVOUS never far back, vied into the lane while between foes, brief lead a sixteenth out, could not last. DENALI TWO PUNCH broke on top, three then four wide turn, could not last. LEVI'S COMING went evenly while racing off the inside. LAKE LUCERNE void of early foot, five wide into the stretch, improved position. OUZO forwardly placed along the inside, lacked a late kick. RUMORS OF PEACE also saved ground to no avail. FIFTH DOWN pinched back at the start, raced well back, came four wide into the stretch, showed some belated interest far out in the strip. KAWANGO tired from early efforts. MY MAN JAY raced well back, five wide late in the turn, finished up well back. BROTHER ALBIE was outrun.
