JERRY N' ELVIS away well, set the pace in hand, pulled away along the inside under steady handling. DAKOTA DIGGER forwardly placed while outside, three wide out of the turn, no match for the winner, held sway for the place. GRAND PRELUDE went evenly paced throughout in the two path. HARLEY devoid of early foot, came five wide out of the turn, found best stride too down the middle of the strip. DESANI'S CHANCE pressured the winner outside that one for a half and weakened. FREE AFRICA broke slowly, five wide late in the turn, lacked a late kick. ONE HUNDRED PROOF four wide in the turn, came up empty for the drive. ATONEMENT lacked speed, improved position slightly while not a threat. PARODY had little for the drive. SENATOR DAVE off a bit slow, advanced four in the turn, failed to sustain that effort in the drive. EL BORREGO tired after a half. GRAND COURT was through early.
