Footnotes

SIR CHEROKEE last away, trailed, circled the field six wide in the second turn, kicked down the leader inside the furlong grounds, continued willingly to the wire, well clear. EUGENE'S THIRD SON closest to the leader, collared that one far turn from the outside, quickly clear into the stretch, proved no match for the winner, well clear of the others. CHRISTINE'S OUTLAW evenly paced, finished best of the others while off the inside. REGION OF MERIT also within striking distance off the inside, lacked a final kick. CROWNED KING void of early foot, lacked room in traffic late in the second turn, bumped, finished willingly when clear. COMIC TRUTH in traffic most of the way, lacked a late kick. SAINT LIAM four wide out of the final turn, no late gain. ARISTOCAT settled off the pace, also came up empty for the drive. DEFRERE'S VIXEN was never involved toward the inside. MAN AMONG MEN four wide in the first turn, advanced middle half mile, gave way when the real running started. SELL TO SURVIVE was never close. CAT GENIUS set a very quick pace and stopped before six furlongs.
