PAYKAY behind the pace while outside, moved up, challenged four wide late in the turn long drive, fully extended to be edging clear late. COURTNMOLLYANNE in the second flight, moved up inside, moved out, challenged three wide and between foes turning for home, proved stubborn until the late going. RHONDA GOT EVEN away in good order, dueled off the inside, narrowly showed the way into the lane, also gave ground grudgingly in the lane. SIPPER broke out, raced well back for a half, moved out, six wide into the lane, finished willingly while too late. FAVORABLE VERDICT broke well, vied up front closest to the inside, weakened in the drive. SMARTY PRANCE bothered off slowly, moved up to middle of the pace in the two path, had little for the drive. JOHNNYESREVENGE five wide and off the pace, came six wide out of the turn, managed little in the way of a rally. LINDA GOT EVEN made little impact while out in the strip. OUR CAREER MOVE well back, moved out a bit for the drive, not a threat. PROMISE THE MOON lacked speed, three wide and in traffic turn, remained back. TOUGH MOUNTAIN prompted the pace for three furlongs and began to stop. SEND ME A KISS vied up front,

checked up into the turn, gave way, eased through the stretch.
