Footnotes

KEWEN chased outside then off the rail, came four wide into the stretch and rallied under left handed urging to be along in time. RAILROAD had good good early speed off the rail then dueled outside a rival, kicked clear into the stretch, found the rail and was caught late. HOLDTHEHELM chased between horses or off the rail, came three deep into the stretch and gained the show late. LENNYFROMALIBU stalked outside then three deep on the hill and into the stretch, drifted in a bit late and was edged for the show. FLORIDA KEYS stalked between horses, continued toward the inside in the stretch, steadied in tight late. BONUS PACK saved ground chasing the pace, was in a bit tight in midstretch and lacked the needed rally. SUNSET PLACE allowed to settle off the rail, came out four wide into the stretch and was not a threat. TRIAL BY JURY chased outside then three deep on the hill and four wide into the stretch and could not summon the necessary response. LICARI stalked the pace inside, came out into the stretch and weakened. THE PHEASANT FLYER (GB) went up inside to duel for the lead, dropped back into the stretch and gave way. A claim of foul by the rider of FLORIDA KEYS against LENNYFROMALIBU for alleged interference in deep stretch was not allowed by the stewards, who ruled the incident minor and that it did not warrant a disqualification. Rail on hill at 7 feet.
