EVENING CONCERTO was slow to settle, angled out then lodged a mild rally. GOOD LORD was well placed into the stretch then weakened. BLACK DIAMOND CAT raced evenly. I AM PRECISION was no factor. MR. GREEN chased to mid stretch then came up empty. MISSISSIPPI HIPPIE rushed to the front inside then stopped after a half. KNEBWORTH refused to break. The race was hand timed.
