### Footnotes

SEA MIST was unhurried early, made a four wide middle move to challenge for the lead leaving the second turn then outfinished MISS ANNIE BEA through the final furlong under brisk hand pressure. MISS ANNIE BEA made a three wide middle move to challenge for the lead leaving the second turn, vied with the winner until late before hanging but was clearly second best. BUZZING B'S angled inside early to duel for the lead, remained a factor to the stretch then gradually weakened. COMPANY STORM sprinted clear to gain the early lead, set the pace off the inner rail for six furlongs then gave way. SUPERFINES LUVEY rushed up inside to press the pace for more than a half then came up empty. SHIRL THE TWIRL showed little. DEHERE'S DREAM was four wide into the first turn then was through early.
