HOLIDAY CHILLS stalked the pace from the two path through the last turn, then drew off late and finished under urging. AFFILYATION pressed the pace from the start, reached contention early, then raced two wide through the second turn and was outfinished in the drive. RIXA MARIE was close up and inside on the far turn, then lacked a late response. BIG TIME RUMBLE was void of early speed, raced four wide on the second turn, then rallied mildly in the lane. BRUTALEE BASHFUL was close up early, raced three wide on the second turn, then faltered late. CRAVING CHOCOLATE pressed the pace early, contended on the backstretch then raced two wide on the last turn and faced thereafter. S W DONNA was void of early speed, raced two wide on the last turn and was not a factor. DEAR CONTENDER set the early pace, was headed on the backstretch then flattened out in the stretch. HOPPING SEATTLE trailed through the second turn then passed tiring rivals. ROCK'N WITH MARY raced two wide on the second turn, then failed to menace. INDIAN PROMISE stalked the early pace from the two path, then was through after a half.
