### Footnotes

BUENISIMA set the pace while saving ground through the turn and finished under urging. GRIZZLY GIRL was void of early speed, raced three wide on the turn, then closed ground willingly. SUNLITSIDEUP pressed the pace from the three path through the turn, then gave way late. STORMY ECLIPSE was slow early, raced two wide on the turn, then finished well. DUAL POWER was close up early, raced inside on the turn, then finished evenly. RUNAWAY STAR was slow early, raced two wide on the turn, then found her best stride late. GENTLE PERSUASION pressed the early pace, raced two wide on the turn then faded. PLEASANT LAYLA was three wide on the turn and failed to menace. CASTLE HAYNE saved ground but lacked a rally. FIRM DOLLAR raced four wide on the turn and was not a factor. TARA'S AFFAIR stalked the early pace, saved ground on the turn, then flattened out late.
