LUVMEALLDAYINDYUSA stayed out from the rail while chasing the early leader, vied outside that one into the final furlong then drove clear through the final sixteenth. RESISTING ARREST stayed out from the rail while making the pace to midstretch then faltered. RIDGEWOOD GRUSHA had early position close to the inside then stopped. GENTLE RYTHMN wasn't far back outside early then stopped. CONTRAINDICATION was outrun two wide. GRACEFUL SWAN stopped inside.
