Footnotes

TOBE SUAVE was never far back, raced three wide on the last turn, then contended late and drew off under urging. NEED TO PROSPER was close up and three wide on the far turn, reached contention late then gave way. TURN TO THE KING set the pace with a clear lead, then weakened late. PAY WHAT YOU OWE saved ground but was not a threat. SPICY VOW was slow early and never a factor. SKIPPING GOLD pressed the pace from the two path through the far turn then faded. WARRIOR CAT stalked the pace from the three path then flattened out.
