Footnotes

NESFIELD stalked the pace from the three path and reached contention on the last turn, then drew off under urging. PARADE SONG was never far back, raced two wide on the last turn, then rallied late and finished second best. SHARP DAY broke outward interfering with PROMISE TO SHARON, then saved the pace while saving ground, was headed on the last turn and gave way, after an objection by the rider of PROMISE TO SHARON for interference leaving the starting gate the stewards' disqualified SHARP DAY from third and placed her fourth. PROMISE TO SHARON clipped heels leaving the starting gate, then raced close up and inside through the far turn while racing evenly throughout and was placed third after claiming foul. DIAMONDSFORJEAN stalked the pace from along the inside through the last turn then weakened. BIG TIME RUMBLE was never far back, raced three wide on the second turn, then made a mild bid late. OCEAN HARMONY raced along the inside on the last turn and failed to menace. EX RATED LADY was close up early, raced along the two path and faded on the last turn. MALIBU CITI pressed the pace from the three path to the far turn, then faltered late. SANDRA LA BELLE trailed the field.
