### Footnotes

SEA WIND stalked the pace from the two path through the far turn, then rallied late and was up in the final strides. R VICARIOUS GIRL pressed the pace from the three path on the second turn, then made a late bid to be second best. FAREENA stalked the pace from the two path, contended on the far turn, then weakened in the drive. DANCERINA (ARG) was slow early, raced two wide on the far turn, angled outward and made a mild bid late. LOVELIER raced along the inside on the far turn and was never a threat. PILOT POINT LADY set the pace while saving ground, was headed on the last turn, then faded in the lane. HOLLY'S WAY was slow early, then stumbled on the backstretch and lost rider.
