FORCE EIGHT vied for the lead soon after the start, raced two wide and drew clear on the last turn, then was ridden out to the wire. STEP SISTER pressed the pace from the three path, made a move on the second turn, then was no match for the winner in the stretch. MY LILY LANE was never far back, raced two wide through the far turn, then rallied late and finished well. SHEZOUTAHERE was unhurried early, raced two wide through the second turn and lacked a rally. WICKED PATTY was close up early, raced along the inside and faltered on the last turn. KINDA KINDA vied for the lead from along the inside from the start, then gave way on the far turn. NICTATE raced along the three path on the second turn while trailing throughout.
