WHERE'S ROSIE B stalked the pace from the two path through the second turn, contended in the stretch then drew off under mild urging. RUNAWAY LIZ set the pace with a clear lead from the start, saved ground throughout, then was headed in mid stretch and gave way. ELEGANT SWAN was void of early speed, raced three wide on the last turn, then found her best stride late. BEALE STREET BELLE was close up early, saved ground on the last turn then faded in the stretch. SAFELY ASHORE was unhurried early, saved ground on the far turn, then lacked a late response. WITTY MISS pressed the early pace, raced two wide on the second turn then faded. COPLA DE ORO raced along the inside on the last turn and failed to menace. QUANTICO QUEEN prompted the early pace, raced two wide on the second turn, then was through after a half. CARLINGFORD lacked speed, raced inside on the second turn and was outrun.
