SMALL PAIR stalked the pace from the three path through the turn, then gained command late and finished under urging. DIVA TIME stalked the pace from the start, contended on the turn then gave way in the stretch. BLACK MANDATE pressed the early pace, raced two wide on the turn, then weakened late. NATIVE CHILD was close up early, raced three wide on the turn then made a mild bid in the lane. DREAMING OF A WIN pressed the early pace, raced three wide on the turn, then lacked a late response. CORKY STONE was slow early, raced three wide on the turn and lacked a rally. GOODFORYOURHEART was void of early speed, raced three wide on the turn and made a mild bid. ABONIA raced two wide on the turn and failed to menace. RUBY'S GONE vied for the early lead, raced along the inside on the turn then faded in the stretch. GIVE IT TO ME raced along the inside on the turn and was not a threat. SOLEDAD'S COURT lacked speed, raced three wide on the turn and showed little. SEA'S FIRST was through early and outrun.
