ISLAND BIRD showed speed inside, moved clear on the turn and was under brisk urging. BAYONETTE showed speed between rivals, stayed out from the rail around the turn and continued evenly through the lane while second best. JUICY LUCY was slow from the gate, raced the three path around the turn and gained late outside. HERO'S CALL dueled outside, raced the three path around the turn and tired. KATIE'S COURT didn't break sharply, was slow early then made up ground too late. PERSONAL CAT tired inside. NIMBLE ALICE dueled early then tired. CHASIN CASH was no factor. WHATARANSOM was outrun. MUNCH'S LIL LADY was outrun. JUDGING ELINOR trailed.
