GOODFORYOURHEART cleared into the first turn, stayed inside and held under urging. BABE'S CHOICE was never far back inside, moved closer on the backstretch then continued evenly. SEEKING THE CITI was unhurried, began a run inside after a half, steadied approaching the end of the backstretch, came out between rivals for the drive and gained mildly. LITE THE LADY was slow to settle, raced the three path around the final turn and outfinished the others in an even effort. SCHILADY stayed close on the outside for over six furlongs then stopped. REAL HOPE was slow to settle, stayed out from the rail around the final turn and tired. ALANA'S DREAM lagged then passed tired ones. COMPELLING CALLER was outrun. MOOD CHANGE stayed close between rivals to the far turn then was eased up through the final quarters. SOLEDAD'S COURT stopped. BUCKLE DOWN JUDY was forced wide on the final turn then was eased up. RUNAWAY JOLIE was making a run along the rail when she fell approaching the lane then got up and ran off.
