PLEASE BE SEATED was away alertly to set the pace racing off the inside rail and was under strong handling to turn back QUIXOTE'S HOPE in the final furlong. QUIXOTE'S HOPE rallied to challenge the winner in midstretch but was not quite good enough. URBAN ANGEL rallied mildly to get up late for the show. SKIP TRIAL MISS raced within striking distance but lacked the needed rally. CHASTER showed little. DANDY DULCE was outrun. LANES LOVE stopped after a half mile. SPANISH CASTLE prompted the pace for a half mile and tired.
