UNDIGNIFIED rated back off the rail, bid into the final turn, dueled to the lead passing the eighth pole then drew away the closing yards. LITESCAMERACTION rated the pace inside, dug in to repulse the challenge of Village Charmer through the upper stretch then grudgingly yielded to the winner the final sixteenth. MASALA T settled back off the rail after breaking inward and steadying at the start, started his drive about the four path on the final turn and closed steadily, just missing place. VILLAGE CHARMER rated off the pace about the three path, drew alongside Litescameraaction nearing the quarter pole and dueled close to midstretch before weakening. REFLECTED WAY rated close inside then faded on the final turn. SUPER DOC appeared awkward leaving the gate and never threatened. GALLANT GULCH came out sharply but soon outrun.
