LOBO DEL NORTE saved ground, angled out when looking for racing room at the head of the stretch, took the lead and drew clear. FISHERTHEFIRECHIEF vied for command just off rail, appeared to be in distress through deep stretch as her shortened stride and was vanned off. JOR EL was outrun early, raced outside into stretch and passed faders. BLUE LIGHT SPECIAL vied for command two wide and tired. TUFRUFF raced outside while just off the pace, tired. TALK ABOUT TIMMY failed to menace. CHIRON raced wide and dropped back. CASEOPEA failed to menace. SUPER AUSTRALIS, wide, failed to threaten. ALLEGHENY FOG showed little. AIDAN OF THE NORTH showed nothing.
