Footnotes

UNCLE GIDGE raced close up along the inside rail then closed between rivals in the final furlong to run down the leader late. WILDCAT BRIEF raced close up outside, drifted in slightly in upper stretch where LOBO DEL NORTE was steadied in close quarters and continued gamely to get up late for second. PLURACITY broke sharp to set the pace while saving ground and fought it out gamely to the end. CHECK IT TWICE, never far back, closed outside rivals through the stretch. LOBO DEL NORTE, forwardly placed, was shuffled back in close quarters between rivals in upper stretch. IRON BULL showed little. WILDCAT BRIEF was disqualified to fifth for interference in upper stretch following a stewards inquiry and objection by the rider of LOBO DEL NORTE.
