SUNSHINE DENISE was outrun early, closed well on the outside. COMPLETION raced two wide prompting the pace and weakened. SCRATCH THE MATCH raced wide and rallied too late. TELEPHONE BOOK saved ground to no avail. DO MY THING failed to menace. DOC'S TREASURE dropped back. TSU TSU ROAN failed to menace. CRAFTY MEME raced three wide and just off the pace, tired. SODA GIRL showed nothing. CROP ANGEL was between foes and just off the early pace, tired badly.
