**Footnotes**

ONE EYED BANDIT engaged for the lead into the backstretch, shook loose on the far turn and won under steady handling. SEA OF FIRE saved ground disputing the early pace and held on well for second while unable to go with the winner. TRI THIS WAY moved closer on the far turn then lacked the needed stretch response. ICROSSMYHART stalked the early pace and lacked a solid stretch response. ROSIE D'ON prompted the pace for six furlongs and weakened in the drive. OK THUNDERBIRD lacked a rally. PIDGEON'S ANGEL showed little. SWEETIE G lunged through the starting gate doors just prior to start to be left several lengths behind the field then following a stewards inquiry she was declared a non-starter and wagers on her were ordered refunded.
