HOME HILL raced and rallied wide, took the lead deep stretch and won going away. LACED UP raced just off the rail and gained place. CUT TO THE CHASE saved ground disputing the pace, was no match. FORMAL FANNY was outside and just off the early duel, challenged near the stretch but then faltered. VIVITZ failed to menace. TRAUMATIC vied for command two wide and tired. STOOGUE LOVER raced outside and tired. LILY VANILLY broke slowly and then trailed.
