RUNAWAY RUBI engaged for the lead completing a half mile to dispute the pace to the stretch then was no match for the winner. IRON CLAD PROOF passed tiring rivals for third. KALKI'S PRIDE broke alertly to dispute the pace and tired. DAYLIGHT ROBBERY vied for the lead from the outset and faltered in the drive. SWEETIE G prompted the early pace and tired. JUDGE BEAUTIFUL was always outrun.
