ICE JULES stalked the pace then moved to the lead in upper stretch, drew clear a furlong out then drifted out in the late yards under left handed pressure. SEEYALATALITIGATA moved closer into the stretch, closed willingly and was carried out by ICE JULES in the late stages. KISSIN DAMSEL broke alertly and set the pace to the stretch then weakened and held on for third. DANEES was unhurried early then rallied mildly to best the others. TEASE was well placed close to the pace then flattened out in the drive. MOLLY'S GOLD showed little. BELLA BACI prompted the pace to the far turn then tired. GONNABREAKEVEN showed little. ITSALLABOUTAMANDA was through early. Following a claim of foul by the rider of SEEYALATALITIGATA against the ICE JULES for interference in deep stretch, ICE JULES was disqualified to second.
