DISCO T broke alertly to set all the pace, turned back a challenge in upper stretch and continued under strong handling to prevail. FOOLISH BID lodged his bid from the outside then closed determinedly and got in a bit in the late stages. TICKET HOME moved up menacingly leaving the far turn then drifted out in upper stretch and gave way, closed gradually in the final furlong and was steadied between the top two nearing the wire. DOESN'T LIE moved up along the inside on the far turn and finished willingly. HOT DEPUTY was unhurried early then responded well in the drive to close outside rivals. BRANDONS BEACH, never far back, lacked the needed response in the final furlong. HIGHFLYINGEMBLEM, forwardly placed, lacked a rally. CALM AND COLLECTED stalked the early pace and weakened. JERSEY MOON tired. Objections by the rider of TICKET HOME against DISCO T and FOOLISH BID for interference in deep stretch were not allowed.
