**Footnotes**

ASHTON GIRL (IRE) was hustled to the lead off the rail inside the opening furlong, urged clear midway through the turn then widened with only mild insistence in the stretch. L GASKA dropped back from a sharp start and brief lead to stalk the pace about the three path, gave chase through the turn and finished well while no match for the winner. CITY APPEAL chased the pace from the outside, came through the turn about the five path then leveled off in the lane. DESIRABLE DESIREE showed no speed two deep, angled to the outside at the top of the lane and finished evenly. ASHLEYS DUE stumbled at the break and never factored. QUIET SIREN chased the early pace from the inside but showed no response on the turn. HEAVY KITTY was not a factor.
