**Footnotes**

JUST CHRISTINA quickly took over a clear lead inside, was well managed to the head of the lane, pressured from there while lugging inward toward the eighth pole, veered out sharply at the sixteenth though lasted well with steady encouragement. TRY AND CATCH ME settled back inside, closed to a boxed in position leaving the quarter pole, eased four wide into the lane and finished well at the withers of the winner. DIXIELAND KNOCKOUT raced near the heels of Just Christina while boxed between horses two deep on the backstretch, eased outside the pacesetter leaving the turn, was shut off steadying near the sixteenth pole and finished evenly from there. AMNESIAN, a step slow to break, advanced toward contention at the rail on the backstretch, steadied lightly into the turn, lacked room through the turn, was shut off in midstretch and raced evenly the remainder. CHATTERTOWN chased the pace toward mid track and finished evenly. MARIBELS GRAYGIRL gave chase about the four path before weakening. ENJOYABLE chased the pace outside and proved empty in the stretch. RAVENOUS showed no speed on the backstretch, lacked room through the turn and had no rally. HUMBLE SONG gave close chase outside through the backstretch then faded on the turn. DAILY CANDY was through early. After reviewing a claim of foul against the winning rider, lodged by the rider of the third place finisher, the stewards disqualified the winner and placed her third for veering across the path of the latter near the sixteenth pole.
