LADY IN THE SUN was outside under rating, challenged and then took the lead mid stretch but couldn't last. SHRIMP TEMPURA was outrun early, rallied wide and finished well. LITTLE BETTY GIRL raced outside moving and was too late. FLAME CATCHER failed to menace. SALEM COUNTY raced two wide, took the lead on final turn, weakened. GOLD LINKAGE failed to menace. CHEVAUX vied for command two wide, tired. GLORIOUS HALO failed to menace. QUEEN AWAD alternated for command inside, tired badly.
