JANEY GIRL was unhurried early, rallied wide and won going away. SWEET TALKIN BABE saved ground dueling for command, was clear in mid stretch but was no match late. ZUCCHINI took up on the far turn when run up on heels, split foes in the stretch and finished well. JOYEUX NOEL saved ground just off the early pace, tired. GUILTY GAL failed to menace. RAPID just off early pace, tired. FEREGE raced outside and just off early pace, tired. COURT SENSE vied for command between foes, tired. SOVRAN ICE failed to threaten.
