STAKES Pennsylvania Derby Grade 3 - Thoroughbred

FOR THREE YEAR OLDS. By subscription of \$500 each which should accompany the nomination, \$800 to pass the entry box, \$1,200 additional to start. The winner to receive \$450,000 with \$150,000 to second, \$82,500 to third, \$45,000 to fourth, \$22,500 to fifth. Weight 122 lbs. Non-winners of \$60,000 at a mile or over in 2003 allowed 3 lbs.; of a sweepstakes at a mile or over in 2003, 5 lbs.; of three races at a mile or over other than maiden or claiming in 2003, 8 lbs. This race will not be divided. A field of 14 horses will be drawn with the preference given to those horses with the highest total earnings at the time of the draw. Starters to be named through the entry box by the usual time of closing on Friday, August 29, 2003. Trophies will be presented to the winning owner, trainer and jockey. Nominations closed Tuesday, August 19, 2003 with 25.

GRAND HOMBRE was allowed to settle early, advanced on the second turn, eased out four wide past the quarter pole, drew off in the stretch to prove much the best, driving. GIMMEAWINK pressed the early pace and made a three wide bid to draw clear on the second turn, proved to be no match for the winner in the final furlong while being second best. ASHMORE was reserved early, advanced while five wide on the second turn, flattened out in the drive while getting up for the show. CHRISTINE'S OUTLAW was well placed early, made a three wide bid on the far turn, but was empty in the drive, missed show. TOCCET was rated early, came three wide into the stretch, but offered no response. DYNEVER was squeezed back at the start, made a six wide move on the second turn, but tired in the drive. VALLEYMAN lacked a serious rally. TAFASEEL was not a factor. DOMESTIC DISPUTE chased the early pace and tired. MAX FOREVER vied for the lead for a half mile and gave way.
